



CONVENIO N° 477-2014-MINEDU

AGREEMENT FOR INTERINSTITUTIONAL COLLABORATION

BETWEEN THE MINISTRY OF EDUCATION OF PERU AND

THE UNIVERSITY OF WESTERN AUSTRALIA, AUSTRALIA

This document certifies the Agreement of Interinstitutional Cooperation for the implementation of Graduate Scholarships between THE MINISTRY OF EDUCATION OF PERU, with RUC N° 20131370998, hereafter THE MINISTRY, with legal address in Calle Del Comercio N° 195 – San Borja – Lima 41 – PERÚ, represented by Dr. Raúl CHOQUE LARRAURI, Executive Director of the National Program of Scholarships and Educational Credit (PRONABEC in Spanish initials), identified with DNI N° 23266921 appropriately authorized to celebrate this agreement as stated in the Ministerial Resolution N° 014-2014-MINEDU, and UNIVERSITY OF WESTERN AUSTRALIA with address in 35 Stirling Highway Nedlands – Western Australia, and with address in Peru for purposes of this agreement in Latino Australia Education, Calle Monte Grande 120 Oficina 219 , C.C. Chaparilla Surco Lima Perú , hereafter THE ENTITY, represented by the Pro Vice Chancellor (International), Mr Iain Watt , who is appropriately authorized to celebrate this agreement according to The University of Western Australia Act 1911 under the terms and conditions expressed as follows:

FIRST: THE PARTIES

- 1.1 THE MINISTRY is the Peruvian instance in charge of defining, directing and articulating policies regarding education, culture, recreation and sports in accordance with the general policies of the State.
1.2 PRONABEC, is the Executive Unit N° 117 of THE MINISTRY in charge of the design, planning, managing, monitoring and evaluating of scholarships and educational credits for higher education with the objective of contributing to equal opportunity in the access of low income students and professionals with academic excellence, as well as guaranteeing their possibilities to carry out and finish the studies and obtaining the respective degrees or titles.
1.3 PRONABEC, subsidizes
1.3.1 Graduate studies related to Peruvian scientific and technological development for professionals with high academic performance and insufficient economic resources in Eligible International Higher Educational Institutions and Universities whom must be ranked among the first four hundred (400) at least once in the five years prior to the respective call in the following rankings: QS World University Rankings, Academic Ranking of World Universities (ARWU), Times Higher Education World University Rankings.
1.3.2 Tuition, pension, study materials, English language course, if necessary, maximum 10 weeks; insurance with health, accident, life and repatriation coverage, research work, certification (administrative costs for obtaining the relevant degree or equivalent), monthly allowance for food, lodging and local transportation and others PRONABEC be determined by the rules of each call, as budget availability; international transport (only at the beginning and end of the academic program), except the repetition of unapproved courses.

1.4 THE ENTITY is The University of Western Australia (UWA) and is recognized internationally as an excellent research-intensive university.

Established in 1911, the University as ground-breaking research, its quality academic staff and state-of-the-art facilities combine to offer a vibrant student experience.

As Western Australia's premier university, UWA was equal first overall in Australia based on key measures in the Good Universities Guide 2012 including graduate starting salaries, employment prospects, staff qualifications, research intensity and student demand.

The University of Western Australia ranks 91st in 2013 by the Academic Ranking of World Universities, published by China's Shanghai Jiao Tong University.

UWA is the only Western Australian university to belong to the Group of Eight – a coalition of the top research universities in Australia – and it is one of only two Australian members of the Worldwide Universities Network, a partnership of 18 research-led universities from Europe, Africa, the Americas and the Asia-Pacific. The University is also a foundation member of the Matariki Network of high quality, research-intensive universities with a particular focus on student experience.

SECOND: BACKGROUND

The Agreement of Interinstitutional Cooperation, between THE MINISTRY and THE ENTITY, exercises the intention of the parts to strengthen their efforts to increase the offer of graduate scholarships with the objective of boosting the human capital with an adequate training, refinement and research promoting competitiveness and scientific and technological development of Peru.

THIRD: LEGAL FRAMEWORK

- 3.1. Law 29837 creates the National Program of Scholarship and Educative Credit – PRONABEC.
- 3.2. Supreme Decree N° 013-2012-ED approves the Rules and Regulations of the Law 29837 modified by Supreme Decree N° 008-2013-ED, dated September 21, 2013.
- 3.3. Ministerial Resolution N° 0108-2012-ED approves the Operations Manual of PRONABEC.
- 3.4. Ministerial Resolution N° 014-2014-MINEDU Delegation of Powers and Duties to the Executive Director to sign this kind of agreement.

FOURTH: GENERAL OBJECTIVE

The general objective of this agreement is to impulse the efforts of THE MINISTRY in building advanced human capital through the awarding of scholarships for graduate studies programs in order to promote the scientific, academic, economic, social and cultural development of the country.

FIFTH: SPECIFIC OBJECTIVE

To promote the access of Peruvian professionals with excellent academic performance and insufficient economic resources to graduate programs offered by The University: Master and Doctoral (Ph.D.) programs related to Science and Technology.

The length of the Graduate Scholarships is determined by the program of choice according to the parameters of THE ENTITY in relation to the Master and Doctoral programs as specified in Annex 1 of this agreement, up 2 (two) years for Masters and 4 (four) years for Doctorates.

SIXTH: COMMITMENTS OF THE PARTIES

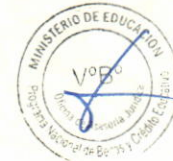
6.1. COMMITMENTS OF THE ENTITY

THE ENTITY assumes the following commitments:

- 6.1.1. Grant a corporate rate (10% discount) to fellows for application costs, registration, tuition fees, and educational services charged by THE ENTITY in Masters and Doctorate studies to fellows of THE MINISTRY, as indicated in Annex N° 2 of this agreement and as are updated on an annual basis and available on THE ENTITY'S web, <https://www.unitcosts.uwa.edu.au/> and <http://www.studyat.uwa.edu.au/courses-and-careers/postgraduate>. Annually, at the beginning of July, THE ENTITY will inform the MINISTRY these costs, also available at <https://www.unitcosts.uwa.edu.au/>, which are the lowest unsubsidized (without discount) of THE ENTITY and for the purpose of holding the Annual Costs Addendum.
- 6.1.2. Grant the acceptance or admission letter to every candidate that has approved all the admission's requirements, including necessary English level, in order to fulfill one of the prerequisites to obtain a scholarship awarded by THE MINISTRY for Master and Doctorate.
- 6.1.3. Facilitate the documentation needed to obtain the Student Visa for the entire length of the Master or Doctorate chosen by the candidate through UWA's inclusion in the Department of Immigration and Citizenship (DIAC) Streamlined Visa Program (SVP). THE ENTITY states expressly to know that this visa, after the fellows have achieved their title shall not be renewed by any reason, because of the obligation of the fellows to return to Peru to accomplish the Peru Service Commitment, through which they must reverse the knowledge acquired in UWA to their hometowns. In that sense THE ENTITY will not make any offer to work of research to the fellows after they have finished their postgraduate studies in UWA.
- 6.1.4. Provide tutoring and academic and psychological monitoring as well as support to Scholarship awardees during their graduate studies.
- 6.1.5. Send to THE MINISTRY, at the end of each academic period, attach to the invoice to registration of the next academic period a complete report on the academic progress and disciplinary status of each scholarship holder based in:
 - Academic Report of the academic period concluded.
 - Report Academic of enrollment in the incoming academic period,

Indicate if there are any pending study subjects and if there are failed subjects. These last must be recovered by the fellow enrolling again but paying the cost, no billing THE ENTITY to THE MINISTRY in the following academic period the study subjects(s) that fellows need to repeat because approving it's their exclusive responsibility.

THE MINISTRY will arrange a written release form (Annex 3) to the student on commencement of studies and provide this to UWA permitting UWA to provide this information to the MINISTRY at the end of each academic period.

- 6.1.6. Provide to each scholarship holder up to 10 weeks of English immersion classes at the Language Center of THE ENTITY, before starting their graduate studies, if necessary.
- 6.1.7. Provide information about the Master and Doctorate academic programs officially accredited, established by both signatories in Annex 1.
- 6.1.8. Provide to THE MINISTRY, the assistance to install in PRONABEC website a direct link to THE ENTITY website, in order to facilitate access to information concerning to Master and Doctorate offered by THE ENTITY.
- 6.1.9. Provide information and advice to the fellows for their access to food and / or lodging.
- 6.1.10. Facilitate to scholarship holders starting their research work from the beginning of their studies in order to have it done by the end of their academic program to achieve their respective title, as part of the Course, up to 2 (two) years for Masters and 4 (four) years for Doctorates study.
- 6.1.11. Facilitate, if possible, a well-equipped research space or office to each scholarship holder of THE MINISTRY in order to guarantee the normal development of their research activities.
- 6.1.12. Not enroll in the next academic term the fellow who scored average disapproval (causal loss of scholarship) and immediately inform the Ministry to take action to the repatriation of the fellow.
- 6.1.13. Communicate to THE MINISTRY any fellows' applying for suspension of studies.

6.2. COMMITMENTS OF THE MINISTRY

THE MINISTRY, through PRONABEC, commits to:

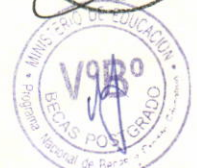
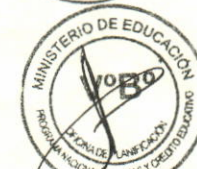
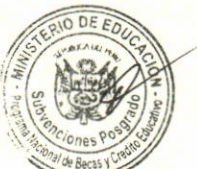
- 6.2.1. Cover for each semester, the entire costs of each Peruvian scholarship holder as indicated in 6.1.1 and 6.1.6. Applicable costs will be invoiced to PRONABEC on a semester basis during the Academic Year, with two semesters the normal enrolment pattern in an Academic Year. Invoices for payment will be provided to PRONABEC approximately February and July in each year.
- 6.2.2. Grant an annual stipend for the concept of living expenses.
- 6.2.3. Grant an annual stipend by study's materials concept.
- 6.2.4. Provide roundtrip flight tickets to each scholarship holder; Lima - UWA Campus, Perth and Albany, Western Australia if applicable (at the beginning of the academic program) and UWA Campus, Perth and Albany, Western Australia if applicable - Lima (at the end of the academic program).
- 6.2.5. Provide insurance with health, accident, life and repatriation coverage to each scholarship holder during their stay in THE ENTITY.
- 6.2.6. Cover the degree certification costs and those indicated in number 1.3.2 ut supra.
- 6.2.7. Communicate to THE ENTITY: name of fellows designated by MINISTRY forty-five days before starting graduate or English studies, accordingly.

6.3 COMMON COMMITMENTS

- 6.3.1. Elaborate a joint work plan every year aiming to achieve the objectives of the commitments contemplated on this agreement.
- 6.3.2. Evaluate and inform the results of the cooperation achieved, identifying the inconveniences and the possible improvements in the execution of this agreement.

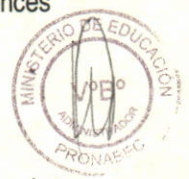

SEVENTH: THE FINANCING

THE MINISTRY will cover the costs of the concepts indicated in numeral 6.2, except the repetition of unapproved courses, and THE ENTITY will assume the costs indicated in numeral 6.1 of the Sixth Article, with the objective that the Peruvian scholarship holders can access, stay and finish their studies in THE ENTITY and the achievement of their title. The financing corresponding to THE MINISTRY is granted according to the Budget assigned annually by the Public Budget Laws of the country and the Law N° 28411 – General Law of the National Budget System of Peru.

EIGHT: INTERINSTITUTIONAL COORDINATION

For the adequate follow up, supervision and monitoring of compliance of the commitments established in this agreement, the parties agree to assign as Inter institutional Coordinators, according to the functions exercised in the implementation of this agreement, the following officials:

By THE MINISTRY

- Responsible : Executive Director of PRONABEC
- Alternative : Chief of the Post Graduate Scholarships Office of PRONABEC.

By THE ENTITY

- Responsible : Ms Deb Pyatt, Manager, International Sponsored Student Unit
- Alternative : Mr Anthony Turner, Manager, International Quality Assurance

THE MINISTRY, through PRONABEC, and THE ENTITY shall substitute their inter-institutional coordinators when considered appropriate.

The substitution must take effect starting the seventh day after the reception of the letter of substitution given by the counterpart.

NINTH: LENGTH OF THE AGREEMENT VALIDATION

The length of validation of this agreement is (04) four years, starting from the date of subscription with an automatic extension of 04 (four) years.

Finalized the length of validation, the commitments assumed by the parts will remain in effect until the total compliance and execution of the pending commitments in process.

TENTH: AGREEMENT MODIFICATION

Any modification, restriction, broadening or extension of this agreement must be done through mutual consensus in writing of the parts and must be formalized by Addendum which will become part of this agreement.

ELEVENTH: SOLUTIONS TO CONTROVERSIES

Any controversy, discrepancy or demand derived from this agreement, including the ones concerning its expiration, nullity, execution, compliance or interpretation shall be settled by THE PARTIES through mutual consultation acting in good faith and in accordance to their common objectives.

TWELVETH: FINAL DISPOSITIONS

- 12.1. The parties subscribing this agreement, expressly state to be subject to Peruvian law in respect of the obligations to be performed in Peru, and Western Australian law in respect of obligations to be performed in Western Australia and that their respective residences are the addresses mentioned in the introduction to this document, in which each other will be passed validly communications and / or notifications as necessary. Any variation of these addresses will be effective the tenth business day of being notified in writing to the other party.
- 12.2. All communications shall be valid and effective if done writing, sent and received via fax, institutional e-mail, certified mail or notarized communication, remitted between those who subscribe this agreement and between Inter Institutional Coordinators, designated by the parties at the eighth clause ut supra..
- 12.3. This Agreement may be terminated by either party. As such:
 - a. The decision shall become effective from the conclusion of the current academic period when being communicated the decision.
 - b. The resolution does not affect the activities and obligations that the parties are developing, which should continue to be met until complete implementation, as appropriate.
 - c. They proceed to settle and pay the costs incurred by the Ministry's fellows through PRONABEC until end of current academic period.
 - d. If fellows do not see for appropriate transfer to another university to complete their studies, the commitments will remain in force between the parties exclusively regarding these fellows, not making new calls for scholarship contest that aim to send new scholarship holders to THE ENTITY.
 - e. The parties shall take the necessary measures to avoid or minimize any prejudice, both among themselves as fellows.

In absolute conformity, the parties proceed to subscribe this agreement in two sets of 03 (three) original copies each, one in in Spanish and the other in English, and both equal in content and authenticity.

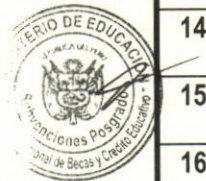

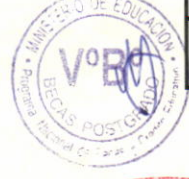
